IDSHS (Aust) Inc. is a NFP Incorporated Society. IDSHS (Aust) Inc. makes no claims as to the availability, fertility, viability, or freedom of disease of semen. There is no breeding contract or live foal guarantee. We have the right to refuse service. The winning Service / dose is final upon delivery.

Semen is supplied under the following conditions:

The semen is supplied for the express purpose of creating pregnancies from owner's mares

Ownership of the semen is not transferable unless authorised in writing by IDSHS (Aust) Inc.

All veterinary charges in respect of the mare/s are the responsibility of the purchaser.

No guarantee of pregnancy is given by IDSHS (Aust) Inc.

Winning ticket purchasers are assumed to have read all information and advice imparted verbally or in writing by IDSHS (Aust) Inc. IDSHS (Aust) Inc. uses reasonable means to ensure that all information and advice provided are accurate. However, IDSHS (Aust) Inc. cannot accept liability for any incorrect information. Winning ticket purchasers are advised to verify the accuracy of all information themselves, and to discuss all issues with the stallion owner and their vet as appropriate.

Liability for semen quality rests solely with the relevant stallion owner.

Liability and risk for the semen and any container in which it is transported in is the responsibility of the semen owner prior to shipping to clients. The semen ownership is handed over to the client at the time it is in transit to your vet, or when picked up from our storage centre and when it arrives at your selected clinic.

IDSHS (Aust) Inc. provides no product exchange or money back guarantee. Once the winners have been drawn, the prize cannot be refunded for the \$ value of the service / dose or exchanged.

All frozen semen supplied is subject to the terms stipulated by the supplying stud. We do not make up these terms. If frozen semen is used, please be aware that you WILL be charged per pregnancy if doses are split and multiple pregnancies obtained, unless otherwise specified in writing. Some stallion owners allow multiple pregnancies while others don't. Please confirm terms with the stallion owner prior to insemination.

Prize includes one service certificate per service / insemination dose.

Frozen doses of semen are a 1 dose – 1 service certificate basis and must be used in full doses only.

Onselling of the semen is not permitted unless IDSHS (Aust) Inc. is notified.
